Ministry of Finance Signs MoUs with 18 Government Agencies to Boost National Trade Digitization

In a major stride toward modernizing Sri Lanka's trade ecosystem, the **Ministry of Finance**, **Planning and Economic Development signed Memorandum of Understanding (MoUs) with eighteen (18) participating Government Agencies (GAs)** on Tuesday, 24th June 2025 at 10.00 a.m. at the Randora Auditorium, Ministry of Finance.

These MoUs are intended to formalize the commitment of all parties and ensure the active support and cooperation of the respective agencies in the successful implementation of the Trade National Single Window System Project - a transformative initiative aimed at digitizing and streamlining cross-border trade processes.









The event commenced with welcome remarks by the Director General of the Department of Trade and Investment Policy, Mr. M. K. Pradeep Kumara highlighting the importance of interagency collaboration in enhancing Sri Lanka's trade facilitation environment.

Following the opening remarks, the Project Director of the Trade National Single Window System Project (TNSWSP), Mr.Neelakanth Wanninayake delivered a brief presentation outlining the project's development framework, key milestones achieved, and the expected support and cooperation required at the ministerial level to ensure effective implementation.

The MoU signing ceremony was held concurrently with the first Inter-Ministerial Coordination Committee (IMCC) Meeting, underlining the importance of inter-agency collaboration in the project's success. Heads of the respective Government Agencies participated in the event as Authorized Signatories, endorsing their institutional support for this national priority.

Need Assessment and Baseline Setting for Implementation of Trade National Single Window System (TNSWS)

Organization entered the WTO Trade Facilitation Agreement in 2017. This agreement aims to streamline import, export and transit trade by facilitating, simplifying and harmonizing the border processes in Sri Lanka. As per one of the measures of this agreement, Government of Sri Lanka has agreed to establish a National Single Window to facilitate import, export and transit trade in Sri Lanka before 31st December 2030. Accordingly, Government of Sri Lanka has decided to establish a Trade National Single Window System (TNSWS) as a single-entry point for submission of application, documents and information by the import, export and transit traders to fulfill border regulatory requirements in Sri Lanka.

Trade National Single Window System (TNSWS) is an electronic entry-point that integrates 18 Government Agencies and 05 Private Sector Chambers that are involved with facilitating and issuing certificates, licenses, permits and recommendations (CLPR). Preliminary studies undertaken by Project Implementation Unit reveal that the readiness of 18 Government Agencies for implementing Trade National Single Window System is found at different levels and their requirements are different from each other. Also, information for baseline setting at Government Agencies for implementation of TNSWS is highly required. So, it is a basic requirement to assess the needs of the said 18 Government Agencies and collect information for baseline setting. Further, this assignment forecasts mainly on the dimensions of business processes, legal and regulatory environment, IT environment and human resource capacities of 18 Government Agencies that have been selected for implementation of TNSWS in Sri Lanka.



Department of Trade and Investment Policy has awarded a contract to Ms. Deloitte Advisory Services (Pvt) Ltd. to undertake a need assessment and collecting information for baseline setting for implementation of TNSWS for 03 months with effect from 18th June 2025. The overall objective of conducting the need assessment and baseline setting is to examining the current status of 18 Government Agencies and providing suggestions and recommendations for future improvements that align with global best practices for Trade National Single Window System briefly. However, the specific objectives of the Need

Analysis and Baseline Setting include the following areas broadly.

- 1. To identify the current status of each Government Agencies.
- 2. To study the existing Certificate, Licenses, Permits and Recommendations (CLPRs) issuing process in Government Agencies.
- 3. To identify the current laws and regulations applicable for each process of Government Agencies in cross-border trade in Sri Lanka.
- 4. To recommend the types of laws and regulations required to be amended or new laws to be enacted.
- 5. To review the existing status of IT environment of Government Agencies.
- 6. To understand the readiness of Government Agencies for Single Window development
- 7. To analyze the existing physical and human resource capacities and their gaps
- 8. To examine the changes to be done for establishment of NSW system, development and future requirement for the establishment of the NSW.
- 9. To set the baseline for project monitoring and evaluation.
- 10. To make recommendation for successful implementation of NSW System based on the suggestions and proposals by the Government Agencies, Chambers & international best practices.

M/s Deloitte Advisory Services (Pvt) Ltd. have submitted an inception report to Project Implementation Unit. This report includes a working plan and timelines of activities of Deloitte. Deloitte have completed meetings with 17 Government Agencies and 03 Private Sector Chambers and issued three questionnaires headed as Need Assessment General Questionnaire, ΙT Questionnaire and HR Capacity Questionnaire to collect information. As soon as the required information is collected from the Government Agencies, Deloitte will submit the final report and make a presentation to the Department of Trade and Investment Policy in the first week and the third week of September 2025 respectively. Need Assessment and Baseline Setting will provide information to take up the implementation activities of TNSWS in the correct path.

Development of "Functional & Technical Requirement Specifications and Preparation of Procurement Documents" for NSW system

We are pleased to announce the official publication of the Expression of Interest (EOI) for procuring a Consultancy Service to support the development of Functional & Technical Requirements and the Preparation of Procurement Documents for Sri Lanka's National Single Window (NSW) system.

This marks a significant step forward in the development of the NSW system and main preparatory action for selecting and mobilizing a suitable vendor for design and develop the Sri Lanka NSW - Sri Lanka's flagship digital trade

facilitation system.



X Scope of the Consultancy Assignment

The consultancy firm or expert team selected through this procurement process will be tasked with delivering two major components that are vital to the successful implementation of the NSW:

1. Development of Functional & Technical Requirement Specifications

This component focuses on ensuring that the future NSW system is comprehensive, interoperable, and aligned with stakeholder needs and global best practices.

Key tasks include:

- Conduct a detailed analysis of the system's functional needs across all relevant stakeholders.
- Functional requirement documentation -Define the key functional areas and use cases that the NSW system must support, including customs declarations, permits and licenses, cargo clearance, risk assessment, payment process.
- Technical Requirement Specification -Ensure specifications support interoperability, scalability, performance benchmarks and security standards suitable for a national-level trade facilitation system.
- Alignment with International Standards -Ensure specifications are compatible with frameworks such as the UN/CEFACT



Recommendations, WCO Data Model, and ASEAN Single Window practices.

2. Preparation of Procurement Documents

- Develop a comprehensive Request for Proposal (RFP)/Bidding Document in line with national procurement guidelines.
- Include a detailed Terms of Reference (TOR) outlining:
 - Roles and responsibilities of the system implementer
 - Clear Service Level Agreements (SLA's), including performance indicators and penalties for noncompliance.
 - A robust evaluation framework to guide selection of the most qualified bidder
 - Legal and compliance clauses to ensure adherence to procurement laws, intellectual property rights, cybersecurity, and data protection regulations

The Trade National Single Window System (TNSWS) Project is a flagship initiative of the Government of Sri Lanka, operating under the Trade and Investment Policy Department of the Ministry of Finance, Planning, and Economic Development. Its goal is to enhance trade facilitation by creating a centralized digital platform for international trade, allowing businesses to submit standardized information and documents through a single-entry point. This system will streamline processes, reduce redundancy, and improve efficiency by connecting multiple Government Agencies (GAs) responsible for issuing Certificates, Licenses, Permits, and Recommendations (CLPR) for imports, exports, and transshipments.

SELECTION OF NSW DEVELOPMENT PATH FOR SRI LANKA;

- AN OPPORTUNITY FOR THE STAKEHOLDERS TO INVOLVE IN THE PROJECT DECISION MAKING PROCESS



Project Implementation Unit (PIU) of the National Single Window System (NSWS) project is in full swing with the blessings of the Trade and Investment Policy Department (TIPD) as the Implementing Agency and Ministry of Finance, Planning and Economic Development as the Executing Agency. After successful completion of the preliminary stage of the project, now their step into Phase I of the Project Implementation stage.

With request of the Government of Sri Lanka, Asian Development Bank provided Technical Assistance for "appraising and recommendation of suitable NSW development path for Sri Lanka". The main purpose of this assignment was to compare the United Nations Conference on Trade and Development (UNCTAD), ASYCUDA NSW system with commercial off-the shelf products (COTS). The findings of the assignment were presented to all stakeholders of the project including 18 participating Government Agencies (GAs) and private sector.





Similarly, with the invitation extended by the Treasury, the UNCTAD, ASYCUDA NSW development officials visited Sri Lanka and made a presentation to the private sector on 06th August 2025 at the Ceylon Chamber of Commerce (CCC). It was an opportunity for the private sector to understand its implementation mechanism, technical details, other features of their product, time taken for development and to clarify certain ambiguities as the beneficiaries of the project.

The event was organized by the TIPD and PIU with the support of CCC. The meeting was chaired by Dr. Harshana Suriyapperuma, Secretary to the Treasury with the participation of Mr. Pradeep Kumara, Director General, TIPD, officials of the PIU, CCC officials and private sector stakeholders. Once again, the TIPD and PIU emphasized their participatory approach in the project decision making process.
